

**INFORMATION PURSUANT TO ARTICLE 13-14 EU COUNCIL REGULATION 2016 679**

We inform you that the data you submitted in both oral and written form are processed by VI.S.A.F. srl located in 14, Rinaldoni street VAT 01293310429 (www.visaf.com- info@visaf.com) which is the proprietor of the treatment of the data.

The data you provided are handled in compliance with the mandatory obligations by law in the fiscal and accounting fields.

The data you provided will principally be treated between the company and the accountant and ultimately data will be transmitted to third parties for the accomplishment of legal obligations (i.e. transmission of invoices to the accountant, transmission of the contracts to legal counsel etc..)(article. 13 paragraph 1.e).

Your data could be communicated to third parties to favour a sound and proper management of the relationship. These data could be communicated in particular to the following categories of recipients including all the duly appointed data controllers: banks and other credit institutions, customers and users, pension and social security institutions. Where the data are of a commercial interest and where the company could draw advantages from the publication (market studies for instance) the abovementioned data could be published in the website of the company.

The holder of the treatment does not intend to transfer personal data to a third country or to an international organisation (article 13 paragraph 1. F).

The collecting of the data consists in elaborating the data collected by third parties which are then processed by electronic computers, manual handling by means of paper filing, reviews and changes of the documents only at a request of a party.

The holder of the treatment has got proper means to ensure a correct storing of the abovementioned data and to prevent them from being stolen or unwittingly spread.

The data will be kept over the entire duration of the commercial relationship. At the end of the commercial relationship the person concerned will have to ask for their restitution, if this is not the case, VI.S.A.F. will keep them as long as it is required (article 13 paragraph 2. a).

The person concerned is entitled of the right to ask VI.S.A.F. for accessing, rectifying, cancelling and limiting his/her personal data in accordance with the second paragraph of article 13.

The provision of data is an essential condition for the execution of the commercial relationship. In the absence of such provision the commercial relationship can not take place, namely it can't start. (article 13 paragraph 2.e).

The present disclosure supplements and replaces the contradictory parts contained in those previously sent.
